

#### PROSPECTUS FOR THE 47TH ANNUAL AHA CONTEMPORARY SHOW 2018

Exhibit Open to the Public Monday, June 11th through Friday, July 27th, 2018 at 1132 Bishop Street, Lobby Level, Honolulu, Hawai'i

### **Eligibility:**

- Entering artists must be AHA members in good standing. To join AHA, go to this link for the membership application: **http://associationhawaiiartists.com/MembershipRenewalForm.pdf** Add \$36 annual dues to the show entry fee when submitting your work.
- All work you submit must be original; we will not accept work produced under instruction or copied from another's work or from copyrighted references.
- Artwork exhibited in any previously juried AHA exhibition is not eligible. Work submitted must have been created within three years of exhibit date.
- · Original (first print) of digital works will be accepted; multiple giclees or prints will not be accepted.

**Submissions:** Digital images of all artwork must be emailed to **suzanne.barnes319@gmail.com** by 6:00 PM on Saturday, May 19, 2018. Images must be 300 dpi and in JPEG format. Email each image separately. Include entry form with each image submission; write 'AHA Show' in subject line, and include price and medium in the message. Title each image as follows: **ArtistLastName-Title-Size.jpg**. Once you have submitted all your images, fill out the entry form and mail it with your entry fee to: AHA 2018 Contemporary Show, PO Box 22274, Honolulu, HI 96823. Checks should be made out to Association of Hawaii Artists (AHA). If you have any questions, email Suzanne Barnes at suzanne.barnes319@gmail.com. Include membership fee/renewal of \$36 payable to AHA with your entry fee submission. Artists will be notified by email of acceptance the week of May 25, 2018.

**Entry Fee:** \$40 for the first three (3) pieces. \$5 for each piece thereafter.

Sets are counted as individual pieces, i.e., diptychs are two entries.

Please review the Entry and Eligibility Rules carefully, as the entry fee is NOT refundable.

Entry Day: Saturday, June 9, 2018, 9 - 11 am. Only works accepted by the juror will be received.

Late entries will not be accepted. Please arrange for someone to drop your work off for you

if you cannot be there on time.

**Juror:** Gregory Pai, PSA, O'ahu art instructor and juror, signature member of the Pastel Society of America.

**Awards:** First Place, Second Place, Third Place, and three (3) Awards of Honor.

**Reception:** Friday, June 15, 5 - 7 pm. Public invited. Artists whose work is accepted into the show are requested to please bring a pupu to share.

**Parking:** The parking garage is located beneath the street. The driveway ramp is mid-block by the pedestrian crosswalk, just before building on the ewa side of Bishop Street going south; there is a flashing light and sign. The building closes on Saturday at 2 pm.

**End of Show and Pick up of Artwork:** Saturday, July 28, 2018, from 10 to 11 am. **IMPORTANT NOTICE:** YOU MUST NOT FORGET TO PICK UP YOUR ART. WE HAVE NO PROVISIONS FOR STORAGE. DO NOT RELY ON US TO REMIND YOU OF THE PICK UP DAY. Artworks not taken back will be subject to donation. Please be aware that the building closes Saturday at 2 pm.

#### PROSPECTUS FOR 2018 ANNUAL CONTEMPORARY SHOW

#### **Display Rules:**

- Wet work or works that are not wired and ready to hang will be rejected immediately.
- No sawtooth hangers on wall hanging works. Frames should be wired to hang.
- We will not accept any entries that require installation with special procedures.
- We suggest that you attach screw eyes or hangers 1/3 to 1/4 the distance from the top of frame.
- Work must remain in the exhibit for the duration of the show.
- Artists with three-dimensional works must provide a dolly, if needed, and be available to assist the committee with installation.
- AHA reserves the right to refuse entry of any work deemed by the Exhibit Committee to contain any of the following: inappropriate content or presentation; inadequate wiring or any other condition that poses an installation problem. The Committee's decision is final.

#### **Commission:**

15% donation to the AHA. Artists discovered to have not paid this will be ineligible to exhibit in future AHA shows for two years.

### **Liability:**

We will handle your work with the best of care. However, the AHA and building management and owners assume no responsibility for theft, loss or damage of any kind. Liability insurance is the artist's responsibility.

### **Other Conditions:**

- Juror may disqualify any work which does not meet requirements of preparation and hanging.
- After entering your art, you will be asked to leave unless you are a part of the installation committee. Artists will not be allowed to talk to the Juror at this time nor browse during installation of the exhibit.
- Prepare your titles with care. Write clearly and legibly. We will print exactly what you write.
- You may not remove your artwork before the end of the show without replacing it with another piece, and then only with the approval of the Exhibit Chair, Juror or President.
